22/00896/VAR - Variation of Condition 2 (landscaping) of planning permission 16/03756/REM (Erection of 11 dwellings following ourline permission 14/00060/OUT(appearance, landscaping, layout and scale to be considered) (revised scheme of 15/01115/REM)

Land west of the Poplars East Street Kilham East Yorkshire YO25 4SG

Applicant: Palladian (York) Ltd. Application type: Variation of Condition(s)

Kilham Parish Council strongly objects to this planning application for the following reasons:- It is felt that the landscaping is always an afterthought when completing a development, in this case the presented plans are very different from the approved ones.

- Dwellings were purchased on this development after been sold the plans showing sympathetic landscaping, with extensive planting and soft furnishings. Considering the length of time the dwellings have been occupied, it would be unfair on the residents that the developer should be allowed to change the plans now.
- The developers have not consulted with the residents who live there.
- It is concerning that the developers removed historic hedgerows during nesting season and have not planted any of the trees as agreed in the original application, how many years should this be allowed to remain uncompleted?
- The developers, as part of the agreed plans, built a public footpath which has not been constructed to an acceptable standard and does not contain any dropped kerbs. The Parish Council since the construction, has been in correspondence with ERYC regarding the inadequacy of the footpath. We have been informed the footpath has been referred to the Development Control Team. If this footpath is not brought up to the correct standard, who will be responsible for future maintenance? This was part of the approved application and whether through planning enforcement, this footpath should be rebuilt to the correct standard with dropped kerbs, to enable ERYC to adopt it.
- This application may not be for the dwellings but the landscaping is just as important to the residents and for developments within an historic village.
