- Playground Gate** - To discuss the playground gate and whether to have a slow closure on it. **639/22**
 It was agreed not have purchase a slow closure gate. A resolution was passed to purchase a sign saying please close the gate, proposed by Cllr Woodward and seconded by Cllr Warrington, all in favour.

 A resolution was passed to claim for the damaged bench via our insurance company, proposed by Cllr Warrington and seconded by Cllr Horner, all in favour.

 It was decided to purchase wooden pointer signs as part of the grant.

 A resolution was passed to apply for a set of gym equipment pieces via the grant, proposed by Cllr Tanner and seconded by Cllr Christie, all in favour.

 The Clerk explained that the legal advise is that the parish council can not fund a local organisation which does not have a bank account. This being the case a resolution was passed to purchase a playmat at a cost of £170 and place it on the parishes asset list. The mat will be located in the village hall for the playgroup to use.
